By drawing readers closer to the characters' struggles and emotions, the narrative evokes empathy and humanizes the victims of oppression, fostering a deeper connection between readers and the themes explored in the text. Oroonoko's transformation from a prince to a leader of resistance inspires readers to reflect on their own capacities for resilience and action in the face of adversity. Additionally, the third-person perspective challenges prevailing stereotypes and amplifies the voices of the oppressed, compelling readers to confront historical and contemporary systems of injustice. In this way, the third-person point of view in Oroonoko transforms the novel into a timeless testament to the enduring strength of the human spirit and a resolute call for empowerment and social change.
